ASK THE DELEGATE

Recently I received a letter from a group within our Area and subsequently the group sent the letter to all the DCMs in Area 74. The letter was addressed to the Area the Treasure and myself and specifically addressed concerns with me. The body of the letter is below.

December 9, 2024

To: Area 74 Treasurer c/o treasurer@area74.org

Area 74 Delegate c/o <u>delegate@area74.org</u>.

A motion has been made, seconded and carried forward by a vote of substantial unanimity of the XXXX Group, Area 74, District 04, to temporarily cease group contributions to Area 74 effective December 1, 2024. This contribution will instead be sent to the District XX Treasurer to be incorporated into the District's bank account and used to carry the A.A. Message to the still-suffering alcoholic. This motion has been considered and voted upon due to disagreement by the XXXXX Group members with the current, and recently past, Area Delegate's discontinuation of soliciting and including GSR votes, on behalf of their respective groups, on Conference Agenda Items at the Area 74 Delegate's Workshop, or at the March 30 Assembly in Rhinelander, preceding the 2024 General Service Conference.

There cannot be any acceptable excuse for this inaction. Accordingly, the Delegate was not properly informed of the Area 74 groups' conscience when he voted at the 2024 General Service Conference. Our A.A. Service Manual states: Every A.A. member has a voice in the Fellowship's present and future – and A.A.'s welfare is central to the agenda of every General Service Conference. As stated in Concept I, "The A.A. groups today hold ultimate responsibility and final authority for our world services – those special elements of over-all service activity which make it possible for our Society to function as a whole." Thus, one of the most important items for an assembly program (or a district meeting) is a good look at the agenda of every General Service Conference. Assemblies and district meetings provide an ideal time to find out our problems and solutions that are shared by A.A. groups everywhere. [Emphasis provided] Without the ability for groups to consider and vote on General Service Conference Agenda items prior to the General Service Conference, the "ultimate responsibility and final authority" of the group is rendered impossible and the "upside down triangle" has ceased to exist. This action, or inaction, appears to be the result of well-intentioned leadership rather than a deliberate choice to follow AA's Traditions and Concepts of Service; however, as most A.A.'s know, the road to our demise is often paved with good intentions. This motion will be reviewed every six months by the XXXXX group with the hope that Concepts of Service is restored to Area 74 trusted servants."

My response:

To: XXX Group, District XX, Area 74,

It is always inspiring to see groups discussing, participating and practicing our steps, traditions, and concepts.

A couple of thoughts have come to mind that I think – which is always dangerous – a *thinking alcoholic* might be helpful for the discussion. What does Concept 1 look like in action? How do we give groups the ultimate authority? How does concept 1 intersect with Concept 2 – which gives the Conference complete authority for the active maintenance of our world services? What does it mean for Concept 3 – which give the "right of decision."

Where does concept 4 land in all of this? Our "Right of Participation". When is the group responsible for participating in the process? I was a bit disheartened and frustrated that the group had been discussing or upset about this issue for some time and the first I heard of this groups' frustration was this letter, dated on December 9th and the decision to suspend financial support of Area Services without discussion or informing myself of the group's dissatisfaction.

Groups of course have the right to send money or not send money. I'm not certain that withholding funds is the most effective way to have your voice heard or to facilitate change – I believe that occurs from one alcoholic talking to another. I was very pleased to receive the letter offering an explanation for withholding funds and that this will lead to robust spiritual conversation.

My hope is that the GSR of this group and or the DCM of this district will bring this issue up to the Area Assembly and begin a conversation. This could be an opportunity for a wonderfully healthy discussion for our Area to have. Our Area Guidelines nor the AA Service Manual as I understand it give clear direction on assemblies voting on Conference Agenda items. For every group that feels one way another group feels another, and we are lead back to our second tradition – our ultimate authority and our subsequent obedience to spiritual principles to stay whole.

My intentions in preparing for the 75th General Service Conference are quite similar to last year. I will be holding a day long delegate's workshop in Wausau on Saturday, March 8th. I will have multiple virtual listening sessions; I will be available to come to your home group and districts and I intend on inviting all the GSRs and DCMS to share their group's conscious at our Area Assembly in April.

I have a sign that hangs in my office that always reminds me of where god is; "the journey is the destination."



The book is intended to help people who have a problem with alcohol gain access to A.A.'s lifesaving message.

For years, A.A. members have expressed a need for a Plain

Language Big Book. Based on the shared experience of A.A. members, some people may not have regular contact with other A.A. members to help them understand the A.A. program of recovery and the specific vocabul ary as it is used throughout the original book *Alcoholics Anonymous*. Other people have a hard time reading, especially books that were written long ago. This *Plain Language Big Book* is written in simpler language to support readers in their recovery.

This book is published in accordance with Advisory Actions passed by substantial unanimity of the General Service Conference (GSC) of Alcoholics Anonymous. In 2021, the 71st GSC advised that this book beadeveloped. Progress reports, then sample chapters were reviewed at the 72nd and 73rd GSCs. The finl d af t d the *Plain Language Big Book* was reviewed and approved by substantial unanimity at the 74th GSC, in April 2024. This process and outcome adopts this text as Conference Approved Literature.

The *Plain Language Big Book* covers the core content of what is the "abridged version" (the edition without personal stories) of the original Big Book.

Readers are also encouraged to seek out the current edition of the book *Alcoholics Anonymous* and meet with A.A. members to support their own individual paths of recovery from alcoholism.
